The Technische Informationsbibliothek (TIB) operates a platform for the publication of peer-reviewed scientific publications (e. g. scientific journals and conference proceedings). In order to be able to provide the publishing services of TIB Open Publishing, TIB must collect and store your personal data.

TIB processes the following data of all customers of TIB Open Publishing

(authors, reviewers, section editors, journal managers/editors, conference organizers, editorial assistants, customers subscribing to updates regarding journals or conferences):

- Contact data (first name and surname)
- Institutional affiliation
- Country of residence

Authors of conference contributions and journal articles:

- Title of the publication
- Names of the authors
- Email addresses of the corresponding authors
- Postal addresses of the corresponding authors
- ORCID of the authors

Reviewers and editors:

- Links to peer-reviewed publications

The data is processed with Open Journal Systems (OJS) of the Public Knowledge Project (PKP)¹ hosted and operated by TIB. TIB is developing partner of OJS. Anonymised data which may be useful for the enhancement of the software is forwarded to PKP.

The publication data is forwarded to the German National Library's New Publication Service and other services as part of the publication process. The names of the editors and their institutional affiliations are published on the website of the publication.

The **legal basis** is § 2 and 14 of the Act on the German National Library of Science and Technology Foundation², and your consent according to Art. 6 para. 1 a) EU General Data Protection Regulation (GDPR)³.

The data will be stored for the duration of your use of the services of TIB Open Publishing and will only be used for the purposes specified here. If you no longer wish to use the services provided by the platform of TIB Open Publishing and TIB has no further claims against you or any other legal reason, we will delete your user account upon request. The personal data of authors, editors, and peer reviewers will be stored for the duration of the publication agreement.

Your rights:⁴

You have the right to obtain information about the data stored in this library at any time, as well as on rectification or erasure or on restriction of processing or -as far as the processing is based on your consent - a right of revocation, if necessary a right of objection as well as the right of data portability. Complaints may be lodged with the above-mentioned supervisory authority.
